September 2018 Examination – Revised Registration Announcement

Online Registration for September 2018 examination started from 06th June 2018 at 3.00 pm.

Note: If an exam in Curriculum 2019 has two applicable subjects in the current curriculum you will need to obtain passes or exemptions in both of these to be able to obtain a pass or exemption in the new subject. This applies to CT1, CT4, CT5 and CT6. If you have a pass or exemption in only one of these subjects, September is the last chance to pass the remaining one. If you have not passed or got an exemption in BOTH examinations you will need to sit the new subject as a whole after the September session.

Below is the procedure for the online registration of examination:

- 1) Log on to your member login (www.actuariesindia.org) by entering your login ID and Password. Once you login, the system will ask you to upload your pass port size photograph, telephone number and email id before moving further.
- 2) Click on the "Examination" -> "September 2018 Examination"-> "Examination Form" tab.
- 3) Select the correspondence address you wish to select "Permanent" Or "Alternate".
- 4) Click on "Edit Profile details" in case you wish to change your Correspondence address, Contact number or Email ID
- 5) It is mandatory to upload your passport size photograph as per the mentioned specification. You will receive a confirmation email in case your uploaded photograph is up to the mark else you will be receiving a rejection email asking you to re-upload the proper photograph.

Do's	Dont's	
Upload your recent passport size photograph (4.5 cm length x 3.5 cm width) in colour	Do not upload black and white photographs	
Background of the photograph should be plain white and the dress should be in dark colour	Photograph with dark background or in uniform, or with eyes hidden under coloured or dark glasses will not be accepted	
Photograph should fit within the given box	Photograph is NOT to be signed	
Frontal view of the full face should be visible in the photograph	Distracting shadows on the face or in the background should not be there	
Print of the photograph should be clear and with a continuous-tone quality	Eyes must not be covered by hair.	
Expression of the face should be natural (no grinning, frowning or raised eyebrows)	Glares or eyeglasses should be avoided with a slight upward or downward tilt of the head	
Eyes must be open and both edges of face must be clearly visible	Photograph should not be damaged, for example: torn, creased, or marked

	Head coverings are not permitted except for religious reasons, but the facial features from bottom of chin to top of forehead and both edges of the face must be clearly visible
Head should be in the centre of the frame and both ears should be visible	Photographs cut from group photographs are not acceptable

- 6) Select the subject(s) you wish to appear in the check box.

 Note: You will only be able to view the subjects for which you have purchased the study material and you can select maximum of three subjects in one examination.
- 7) Select the Examination centre which you wish to appear from the drop down list.
- 8) Click on "Pay" tab to make the payment of examination fees.
- 9) On successful payment you will be directed towards "Transaction Acknowledgment" page.
- 10) Click on "Proceed" to view your registration details.

Registration for Additional Subject

If you wish to register for an additional subject, you need to follow the same registration process as mentioned above.

Change of Centre

You can change your Centre any time on or before **08**th **August 2018** by going to "Examination" -> "September 2018 Examination"-> "Examination Form". Select the centre you want to change and click on proceed.

- 1) Online Registration started on **06**th June **2018**, Wednesday at 3.00 p.m.
- 2) Last date of Registration without late fee is **04**th **August 2018**, Saturday up to 3.00 p.m.
- 3) Last date of Registration with late fee is **08th August 2018, Wednesday** up to 3.00 p.m.
- **4)** Last date to receive Overseas Exam Centre Requests (complete with the required information) by Ms. Swapnil Gupta at swapnil@actuariesindia.org is **24**th **July 2018** up to 3.00 p.m. (Refer Note on Overseas Exam Centre available on IAI website for more details)
- 5) Hall ticket will be made available to download under your respective member login by 25th August 2018.
